**12.01 Parks Defined.** (1) The term "park," wherever used in this Chapter, means all of the lands and water owned or used by the Village for park or recreational purposes, except those lands leased to others.

(2) Parks in the Village governed by this Chapter include, without limitation:

- (a) Bigfoot Park;
- (b) Bradley Park;
- © Dudley Davis Quarry Park;
- (d) Entrance Parks;
- (e) Four Corners Park;
- (f) Kaeser Woods;
- (g) Marina;
- (h) McKenna Park;
- (I) Outlot A;
- (j) Post Farm Park;
- (k) Reese Woods; and
- (l) Village Hall Grounds (old and new).

**12.02 Management.** The parks are under the jurisdiction of the parks committee, as prescribed by section 2.02(10)(b)2.

**12.03 Unlawful Conduct Prohibited.** No person may commit any of the following

acts in or upon any park:

(1) **VANDALISM.** Soil, deface, injure, remove, damage, upset, destroy, or otherwise vandalize any building, fence, fountain, bench, table, receptacle, fireplace, tree, bush, flower, or other property situated, used, or kept upon park grounds.

(2) **FIRE.** Light any fire except in a fireplace, pit, or charcoal burner provided in the park. Private charcoal or gas burners may be used.

(3) **LITTER.** Litter in any fashion. Litter includes, without limitation, glass, boxes, and refuse, or other items, liquid or solid, which are not properly disposed of in a Village-approved refuse or recycling container.

(4) **REMOVE OR MOVE PARK EQUIPMENT.** Without the approval of the administrator or crew chief, remove any item of park equipment, including, without limitation, a bench, seat, or table.

(5) **FIREWORKS.** Use any fireworks except when the proper permit has been issued under section 8.03(2) of this Code.

(6) **SALES.** Engage in the sale of any item without the proper permit issued under

section 17.05 of this Code and the permission of the administrator or crew chief.

(7) **SIGNS.** Place any sign without prior approval of the administrator or crew chief.

(8) **CAMPING.** Camp or set up a tent, trailer, or any other temporary shelter without prior approval of the administrator or crew chief.

(9) **GLASS CONTAINERS PROHIBITED.** It shall be unlawful for any person to bring or possess glass containers at the Village marina and in McKenna Park.

**12.04 Regulation of Hours of Use of Public Facilities.** No person may frequent, use, be in or be present at any park before the hour of 5:00 am or after the hour of 10:00 pm on any day. This section does not apply to any person specifically authorized by the Village Board, administrator, or police chief to be in a park between the hours of 10:00 pm and 5:00 am.

**12.05 Motor Vehicles Regulated; Snowmobiles and Other Off-the-Road Vehicles Prohibited.** (1) **MOTOR VEHICLES.** No person, except Village personnel, may drive or park a motor vehicle in any park except on a road or in a parking lot designated for the use of motor vehicles.

(2) **SNOWMOBILES AND OTHER OFF-THE-ROAD VEHICLES.** The operation of snowmobiles and other off-the-road vehicles is prohibited in all parks.

**12.06 Park Rules.** All rules and user fees adopted by the Village Board and on file in the office of the administrator for regulation of the use of the parks are hereby incorporated by reference.

**12.07 Penalties.** Violations of any provisions of this Chapter shall be subject to the penalty provision set forth in Section 31.05 of this code.
