

SHOREWOOD HILLS LAND REC PROGRAM 2008

The Land Recreation Program is ready for a busy summer in 2008. The program is an eight-week summer program. Children who are age 7 (by September 1) through age 11 (entering sixth grade) and who live in Shorewood Hills, Eagle Heights and University Houses are eligible to participate. Also, any child who does not live in these areas but was a student in grades one through five at Shorewood Hills Elementary School in 2008 may participate.

The program consists of 2 sessions: June 16 - July 11 and July 14 - August 8. Children are enrolled by the session, and may enroll in either or both sessions. The cost per session is \$90. Space is limited.

The program is from 1:00 pm to 3:00 pm – Monday through Friday at the Heiden Haus at the southern end of the Shorewood Hills School playing field. Activities include games, arts, crafts, sports, field trips, and supervised playground activities. The program is cancelled on bad weather days (rain, heat advisory, etc.). Applications received by **March 28th** will be processed on **March 28th**. Later applicants will be admitted as space permits, due to hiring considerations. There is no guarantee that applications received after **March 28th** can be accommodated. Late applications will be processed by the program director if space is still available.
